## **Instructor/Practitioner Agreement**

Dear Universal Tao Instructor or Practitioner,

Congratulations on having completed the necessary requirements for receiving this certification. Listed below are the terms and conditions of certification & the statement of ethics. Please read carefully and sign on the line below to indicate that you understand and agree to all the terms and conditions. Return this signed form to the address on the other side, along with your photos indicated on the back.

### ***Terms and Conditions of Certification including a Statement of Ethics***

1. The highest standard of ethical and moral conduct is required for certification as an Universal Tao Instructor, Instructor or Practitioner shall conform to the "Standard of Ethics" set forth by the Instructors/Practitioners Associations.
2. In order to keep a high standard of qualification, certification is limited to a period of three years from date of issue. Instructors/Practitioners must review the practices for which they are certified as a preliminary to recertification. All previously Certified Instructors & Practitioners must attend refresher courses to maintain an updated body of knowledge regarding Universal Tao practices. Those who have not actively taught for three years or more and didn't review will be dropped from the Certified Instructors mailing list and moved to the Non-active Instructors List.
3. Please remember that you are only allowed to teach the practices you are certified in.
4. Membership in one of the Instructors/Practitioners Associations and conformity to their rules and regulations is a requirement for certification. A member must maintain good standing with regard to dues established by the Association, and membership must be kept current.
5. Fees for instruction offered by the Instructor or Practitioner shall not exceed the recommendations of the Instructors/Practitioners Associations.
6. Certification by the Universal Tao Center carries no expressed or implied insurance coverage for liability incurred while instructing the Universal Tao practices. Liability insurance should be maintained by each individual Instructor/Practitioner.
7. Certification by the Universal Tao Center carries no expressed or implied authority to engage in medical or healing practices. Universal Tao certification is for instructing individuals to care for themselves. Use of any of the Universal Tao techniques for medical purposes can only be performed under supervision of qualified medical personnel.
8. No instruction may be given to any person under the age of 18 years without prior express written consent of a parent or legal guardian. Such express written consent must be maintained on file by the Instructor or Practitioner.
9. Only approved instructional materials may be used as a part of Universal Tao instruction.
10. As a certified Instructor/Practitioner you are entitled to use the Universal Tao Center name and logos to promote your instruction. Any commercial products (such as books, booklets, videos, tapes, or CDs) based upon Universal Tao tenets and/or practices that you produce & market are subject to a contract from the Universal Tao Center & an agreed 5% of net proceeds as a royalty.
11. All Instructors and Practitioners should maintain records of attendance of all students participating in Universal Tao courses. The record should contain the student name, address, date of birth, title and date of the course completed. These records should be furnished to the Universal Tao Center as required.
12. All Instructors and Practitioners are required to sent their students addresses to the Universal Tao Center for global mailings and communications and having an email address.
13. An Instructors and Practitioners should have permission from the Universal Tao Center to do mailing or to advertise outside his/her own area. As a courtesy, also inform the local Instructors or Practitioners.
14. Violation of the above terms and conditions of certification, standards or ethics of the Instructors/Practitioners Association, or the rendering of improper training or instruction will result in the immediate revocation of certification.
